

## God is Good Gamez **GDA Agreement**:

As a God is Good Gamez (GIGG) <u>GDA (Going Deeper Ambassador)</u> <u>I agree</u> to the following statements and understand that some statements are about <u>motivation</u> and desire and others are about actions:

"I desire to keep <u>practicing personally</u> the <u>process</u> of asking for <u>and</u> receiving God's intimate love <u>and</u> forgiveness for myself in every area of my life."

"I desire to keep learning how to lead by example GIGG participants in getting the most out of their GIGG experience by tracking my points using the "EZ Track My Going Deeper Points" on the GIGG website."

"Before any game gathering that I organize I will seek to take <u>10 minutes</u> to be <u>alone</u> with God and invite Him to help me to give <u>Grace</u> to all gathering participants, to be <u>Patient</u> with all gathering participants and to be Consistent to follow all instructions from the GIGG GDA Handbook."

"I understand and agree that the desire of my heart is personally 'following Jesus' and growing in my relationship with Him so my behavior less and less resembles Romans Chapter 1:18-32 and more and more resembles the fruit of the Spirit in Galatians 5:22-26."

"I understand and agree, based on the holistic interpretation of scripture that GIGG is **not** demeaning me in any way by requesting that my above mentioned desire to follow Jesus be consistent with my public, <u>legal marriage</u> choices."

"I understand and agree that claiming to wholeheartedly follow Jesus with my life while <u>publicly</u>, <u>legally</u> entering into or maintaining any union which is <u>by definition</u> and common understanding <u>not</u> <u>consistent</u> with the behaviors and attitudes warned against in Romans 1:18-32 is not preferred or logical."

"I understand and agree that GIGG's <u>decision</u> to <u>not</u> associate with me as a GDA or <u>ending</u> of the association as an GDA is based solely on a difference of interpretation and definition of logical congruence and <u>not</u> based on any discrimination or 'hate' of me or my rights to make <u>personal</u> choices."

"I understand and agree that there is a large difference between <u>participating</u> <u>in</u> GIGG, which is open to all people; all beliefs; all personal choices and <u>associating with</u> GIGG as a GDA." **Example**: It is polite to smile and treat <u>everyone</u> on the street you meet with respect, but to <u>associate</u> in a business partnership a person is <u>not</u> <u>hateful</u> if they require certain similar philosophies to be present in order for both parties to go forward."

"I understand and agree that if I <u>perceive</u> any <u>unequal</u> respect for my intrinsic value based solely on my personal choices from <u>anyone</u> associated with GIGG I will deal <u>only</u> privately with GIGG ownership via email or phone to <u>resolve</u> these feelings."

"I understand and agree that, even though I am <u>not</u> an employee of GIGG, the "at will" standard that applies to employer/employee associations <u>does</u> apply to the association between myself and GIGG. Simply put, for any reason either party can end the association and agrees to not seek legal compensation for perceived damages."

"I understand and agree that it is possible for GIGG to say "no" to an association with me as a GDA for various reasons, but that "no" is not based on race, sex, gender or sexual orientation."

"I have read the GDA Handbook."

"I understand and agree to refrain from <u>public</u> 'disagreements' with <u>any</u> volunteers <u>during</u> the GIGG gathering. Instead, I will offer feedback and have 'debriefing' sessions with volunteers (See Rule of four) after a gathering."

"I have completed a background check and made 2 copies. One for my records and one for GIGG records." (Email to dblcookies@gmail.com)

"I understand and agree that I am required to report <u>any</u> changes to my criminal record to GIGG immediately and this may affect my association with GIGG."

"I have read and understand the GIGG "Code of conduct" and "Rule of Four" and <u>desire to</u>, with God's help, *remain* aware of the guidelines and guard against the temptation to "lower my standards."

"I understand and agree that GIGG is not required to *guarantee* I follow the Code of Conduct and Rule of Four and is *not responsible* for any actions I take at any time."

"I understand and agree that my <u>confirmed</u> violations of any "zero tolerance" behaviors listed in the Code of Conduct will result in the immediate ending of my association with GIGG as a GDA."

"I understand and agree that my confirmed double 'violation' of any "two strikes" behaviors listed in the Code of Conduct will result in *suspension* of my association with GIGG as a GDA for 3 weeks."

"I understand and agree that, if I choose to associate as a GDA after suspension (3 weeks) and <u>again</u> commit a <u>single</u> "two strike" behavior I will <u>never again</u> be able associate as a GDA and organize formal GIGG gatherings. (Formal gatherings <u>only</u> are listed on website)"

"I understand and agree that ending my association with GIGG as a GDA is the <u>only</u> action that GIGG will take in response to a documented 'zero tolerance' action or a <u>repeat</u> of a 'two strike' action. I can still track personal points via website."

"I understand and agree that all GIGG ownership, GDA, volunteers and participants will report <u>any</u> illegal activity that I do <u>if they become aware of it</u> to the appropriate authorities. Verified assault against any listed above is included."

"I understand and agree that as a part time GDA, making 'tons of money' is not my motivation."

"I understand and agree that I can receive as 1099 income 9% of any Loyalty Partner (LP) and Business Partner (BP) funds submitted through the GIGG website that include <u>my name</u> and are designated for rewards.

"I understand and agree that any 1099 income only *continues* for GDA still associated and in good standing with GIGG."

"I understand and agree that I am responsible to get a GIGG registration form (appropriate for the state of the participant) signed by <u>every</u> participant (or parent/guardian) in any gathering that I organize as soon as possible. (See Registration Form)"

"I acknowledge that I am over age 18 and all information I am giving is accurate to the best of my knowledge."
